Objective and investment policy

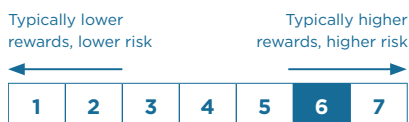
The Impax Environmental Leaders (Ireland) Fund seeks to achieve sustainable, above market returns over the longer term (5+ years) by investing globally in companies active in the growing Resource Efficiency and Environmental markets. These markets address a number of long term macro-economic themes: growing populations, rising living standards, increasing urbanisation, rising consumption and depletion of limited natural resources. Investments are made in companies which have >20% of their underlying revenue generated by sales of environmental products or services in the energy efficiency, renewable energy, water, waste and sustainable food and agriculture markets. The investment decision process is based on multi-year trends including impacts arising from population changes, infrastructure issues, scarcity of resources and environmental issues. The Fund aims to invest in companies that display positive environmental, social and governance attributes.

The Fund has been classified as an Article 9 financial product for the purposes of Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability-related disclosures in the financial services sector ("SFDR").

The Fund is actively managed and is not managed in reference to a benchmark.

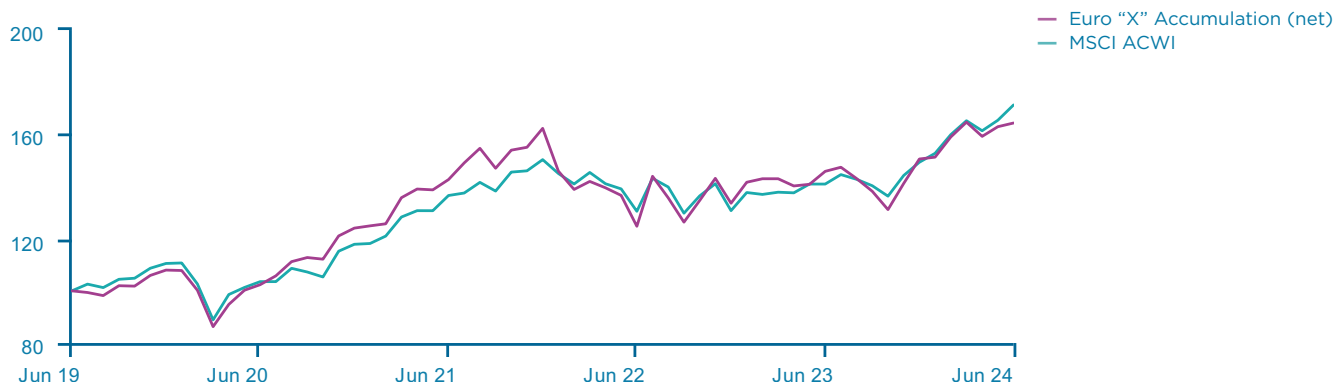

General risks
