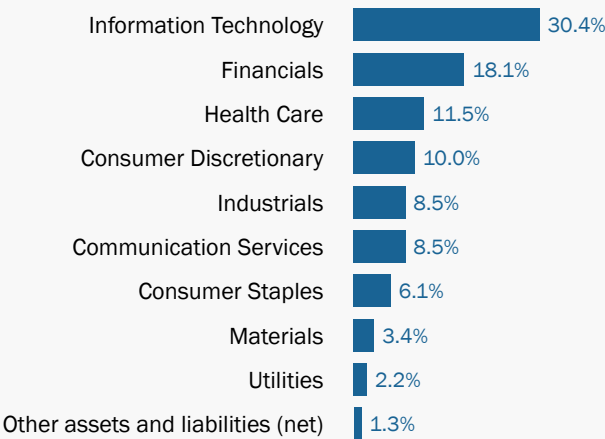

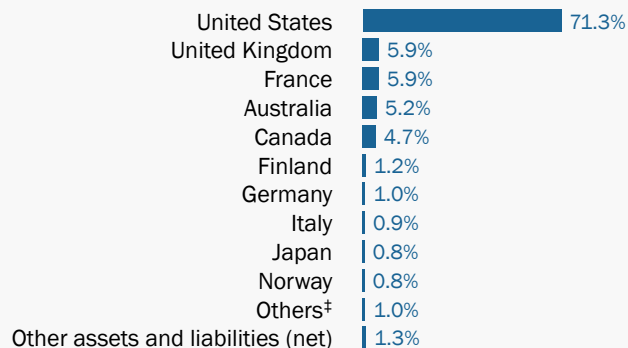
Sector Diversification as of June 30, 2026 * ^

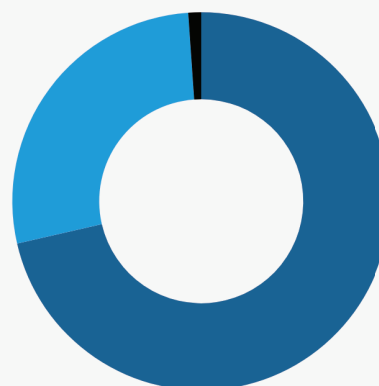
Geographical Diversification as of June 30, 2026 [^]
