connection with the funding of construction or operating assets. NEI has made direct or indirect investments in Ireland, Spain, Germany, Greece, the UK, Portugal and elsewhere.

Impax New Energy Investors LP reached its target size of €125 million in August 2006 and benefits from a range of high quality institutional investors, including leading UK pension funds. Impax is seeking to build on this foundation by further diversifying its long term investor group.
