

Impax announces the launch of Environmental Leaders Fund

London, 26 January 2016 - Impax Asset Management ("Impax" or the "Company") the specialist investment manager, focused on environmental markets and related resource efficiency sectors, today announced the launch of Impax Environmental Leaders Ireland Fund (the "Fund") under the Company's existing Irish UCITS umbrella structure¹.

The Impax Environmental Leaders Fund seeks to exploit the opportunity of the growth in environmental markets for long term investors. The Fund is based on the Impax Leaders Strategy which has a seven year track record². The AUM of the strategy was £506 million as at 31 December 2015.


The Fund invests globally, providing exposure to resource efficiency companies across the market cap spectrum. The underlying companies of the Fund tend to have higher market capitalisations than those in our Specialists strategy (which includes Impax Environmental Markets plc) and the Fund has a lower tracking error and slightly higher yield. This should be an appealing alternative product offering for clients that have an interest in participating in the transition to a more sustainable economy.

Bruce Jenkyn-Jones, Head of Listed Equities at Impax, said:

"We are pleased to expand our product range for UK investors. We believe that the Impax Environmental Leaders Fund is well aligned with strong growth in investor interest in positive climate and environmental solutions. Investors are waking up to the inevitability of the long term decline of the energy and natural resources sectors and an accelerated shift towards decarbonisation. Last December's Paris Climate Agreement is proving to be an additional strong catalyst for these markets."

The manager seeks to select stocks with the most attractive return-risk factors. The portfolio is expected to number 40 – 60 stocks and to have a low turnover. The Fund has no strong geography bias (54% North America, 27% Europe, 17% Asia including Japan³). It is broadly diversified across environmental markets.

The Fund is managed by Hubert Aarts who has been Lead Portfolio Manager of the Leaders Strategy since inception. Hubert will be supported by Bruce Jenkyn-Jones and David Winborne and the 12 strong equity equity team.

Impax's investment thesis is predicated on the drivers of population growth, urbanisation, resource scarcity, environmental constraints and a global infrastructure deficit. These drivers continue to gather momentum and we believe that environmental and resource efficiency markets should offer long-term investors strong growth in a low-growth macro environment.
